Candidates should have attained age of 18 years and should not have completed 29 years as on **01.01.2017** The upper age is relaxable by 03 years for candidates belonging to OBC communities, by 05 years for candidates belonging to SC/ST communities.

 - (vi) Divorced/Judicially separated Women: Copy of Decree from the competent court of law for having divorced/judicially separated along with an Affidavit that she has not remarried since should be enclosed.
 - (vii) Widow: Death certificate of her husband together with an Affidavit to the affect that she has not remarried since, should be enclosed.
 - (viii) Ex-Servicemen: Discharge Certificate should be enclosed.
 - (ix) Persons with Disability: Disability Certificate issued by Medical Board of appropriate Government should be enclosed.

Candidates belonging to economically backward classes will mean the candidates whose family income is less than Rs.50,000/- per annum. The following authorities are authorized to issue income certificates for the purpose of identifying economically backward classes:

- 1. District Magistrate or any other Revenue Officer up to the level of Tahsildar.
- 2. Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
- 3. Union Minister may also recommend for any persons from anywhere in the country.
- 4. Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.

<u>Note</u>: BPL Card or any other certificate issued by Central Government under a recognized poverty alleviation programme **or Izzat MST** issued by Railways will also be valid.

The certificate for refund of fee in respect of candidates belonging to economically backward classes who actually appear in the written examination is required to be issued on the letter head of the issuing authority as per the format enclosed as **Annexure 'C'**.

- (v) Serving employees should submit their applications through proper channel as per extant rules.
- (vi) More than one application from one candidate for same discipline will not be accepted and all such applications will be summarily rejected.
