2. **PAY SCALE:** Rs. 10300-34800 + 4200/- Grade Pay

Regarding drawing the pay of the appointed candidate, <u>as per Notifications No. 7/204/2012-4FP1/66</u>, <u>Dated 15/01/2015 of Govt. of Punjab Department of Finance (Finance Personnel-I Branch) Chandigarh, fixed emolument equal to Minimum of the Pay Band without any Grade Pay or any allowance will be paid during the probation period of 2 years. It is also clear that Annual increment or any other allowance except travelling allowance will not be paid during the probation period of 2 years.</u>

3.0 <u>ESSENTIAL QUALIFICATIONS</u>:-

- i) Should be a Law Graduate from a recognised University or institution and,
- ii) Should have practiced at the Bar for minimum period of two years or should have held an assignment involving legal work under the Government of India or a State Government or a public undertaking for a minimum period of two years.
