Applications are invited in the prescribed format as given in Annexure-A hereunder, from eligible Indian citizens for recruitment against Cultural Quota for the year 2016-17 for two Group 'C' posts in Pay Band-1 (Rs. 5200-20200) with Grade Pay Rs.1900/2000 on N.E. Railway.

- (1) **Details of posts:** (A) Male Actor for drama- 01 post (B) Male Singer (Sugam Sangeet)-01 post. No post is reserved for any particular community.
- (2) **Essential Qualifications:** (i) For technician-III, Matriculation or its equivalent with ITI in relevant trade (Recognised by SCVT, NCVT) and for other posts, 12<sup>th</sup> or its equivalent with 50% marks in aggregate. The compulsion of 50% marks in aggregate will not be insisted upon in case of SC/ST/Ex-Servicemen candidates (ii) Candidate should possess Degree/Diploma/Certificate in Drama/Music from Government recognised Institute.
- (3) **Desirable Qualification :** (i) Experience in the field and performance given on All India Radio/Doordarshan etc. (ii) Prizes won at National level.
- (4) **Age:** 18 to 32 years. Age will be reckoned as on 01.01.2017. The upper age limit is relaxable as under, subject to submission of requisite certificates: (A) By 05 years for SC/ST Candidates (B) By 03 years for OBC Candidates (C) Up to the extent of service rendered in Defence plus 03 years for Ex Servicemen provided they have put more than 06 months' service after attestation (D) By 05 years for candidates who have ordinarily been domiciled in the State of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989 (E) By 10 years for persons with disabilities (PWD) (13 years for OBC and 15 years for SC/ST). (F) Upper age limit for widows, divorced women and women judicially separated from husband but not remarried shall be 35 years for UR, 38 years for OBC and 40 years for SC/ST. (G) For serving Railway Staff, casual labour and substitutes, the upper age limits will be 40, 43 and 45 years for UR, OBC and SC/ST respectively, provided they have put in a minimum of 03 years service. (H) For those working in Quasi-Administrative offices of the Railway, the upper age relaxation will be up to the length of service, subject to a maximum of 05 years.
- (5) **How to apply:** (i) Candidate should carefully read all the instructions given in the employment notice before filling the application form. (ii) Application shall be submitted on

good quality white plain A4 size paper in the format given in Annexure-A hereunder using only one side of the paper. (iii) The application should be filled either in English or Hindi in the applicant's own handwriting using a blue or black ball point pen. (iv) Serving Government employees should send their applications through proper channel duly forwarded by their controlling officers. The last date will not be extended on account of delay in transmission of the application by the concerned office. However an advance copy of the application may also be submitted. (v) Candidates claiming age relaxation or refund of Examination Fee must submit self attested copies of the requisite certificates, issued by the appropriate authority.

- (6) **Whom to apply:** Application in the prescribed format, complete in all respect along with all the enclosures should be sent by ORDINARY POST ONLY to Senior Personnel Officer, Railway Recruitment Cell, N.E. Railway, CCM Annexe Building, Railway Road No. 14, Gorakhpur (UP)-273012 or may be dropped in the box kept at the premises of Railway Recruitment Cell, Gorakhpur between 09.30 hrs to 18.00 hrs. on any working day on or before the last date of application in an envelope duly superscribing "CULTURAL QUOTA"
- (7) **Examination Fee:** (i) For all candidates except those mentioned in sub-para (ii) below: Rs.500/-(Rupees Five Hundred only). (ii) For candidates belonging to SC/ST/Ex-servicemen/Persons with disabilities (PWDs), Women, Minorities and Economically Backward Classes: Rs-250/-(Rs. Two Hundred Fifty only), which will be refunded to those candidates who actually appear in the written examination. Fee will be in the form of Indian Postal Order (IPO), drawn in favour of Senior Personnel Officer, RRC, N.E. Railway, payable at Gorakhpur. IPOs issued before the date of issue of this Employment Notice will not be accepted and the Application form will be rejected. Applications received with fee in the form of Demand draft/Cash/Cheque/Central Recruitment Fee Stamps and Money Orders will not be accepted and application form will be REJECTED. Candidates must write their name and full address at the space provided in the postal order. Save as stated above, the examination fee is not refundable/transferable/adjustable under any circumstances.
- (8) **Recruitment Process:** The eligible candidates will be assessed on the following basis.  
(A) Written Test consisting of 50 objective type questions-50 marks (B) Assessment of talent in the relevant field: (i) On the basis of practical demonstration-35 marks (ii) On the basis of Testimonials/Prizes etc-15 marks. (Total 100 marks)
- (9) **General Conditions:** (i) A candidate shall be called for Written Examination only if he/she fulfils all the laid down eligibility criteria. (ii) Before applying, the candidates should ensure that they fulfil all the eligibility norms. The educational or Cultural qualifications acquired after the date of application shall not be considered. (iii) Candidates attempting to give false information/suppressing the facts will be disqualified and are liable for debarment and legal action. Candidates who attempt fraud/impersonation are liable to be debarred from appearing in the future examinations conducted for recruitment in Railways. (iv) Candidate(s) found eligible for appointment have to pass the prescribed medical examination conducted by the Railway administration before appointment. (v) Mere selection of candidates and recommendation for their appointment shall not confer any right on the candidates for their appointment in Railway. (vi) Second class Free journey passes from the nearest Railway station mentioned in the application form will be issued to the candidates belonging to SC & ST communities whenever they are called at any stage of recruitment. (vii) The person appointed against Cultural Quota to the category of clerks will be required to possess

proficiency in typing within a period of two years from the date of appointment, and their appointment will be provisional subject to acquisition of the prescribed typing qualification within the stipulated period. In case of non acquisition of typing skill within the prescribed period, no additional time will be given and services of such candidate(s) will be summarily terminated. (viii) Candidates belonging to Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahoul and Spiti districts and Pangi Sub-division of Chamba District of Himachal Pradesh, Andaman & Nikobar and Lakshwadeep Islands should enclose a domicile certificate or a certificate of having passed the qualifying examination from the school/college situated therein.

**(10)List of enclosures:** (i) Indian Postal Order for Rs. 500/- or Rs. 250/- as the case may be. SC/ST, Ex-servicemen, Persons with Disabilities, Minority candidates and candidates belonging to Economically Backward Classes should enclose self attested copies of the certificates issued by appropriate authority. (ii) Self attested copies of educational/technical certificates. (iii) Self Attested copies of Cultural qualifications/event certificates issued by Authorised Signatories for events. (iv) For OBC Candidate the caste certificate must be on the prescribed format for employment under Govt. of India (v) Self attested copy of 10<sup>th</sup> class or equivalent certificate as proof of Date of Birth. (vi) Income Certificate in case of Economically Backward Class candidates.

**(11)Invalid Applications:** Applications not in the prescribed format, not completely filled or filled/submitted in contravention of the above mentioned instructions will be summarily rejected. Apart from the above, following are the main grounds for rejection of application form: (i) Application forms received through Registered Post/Speed Post/Courier. (ii) Application not on the given format (iii) Incomplete/illegible application forms (iv) Applications without prescribed Examination Fee (v) Necessary certificates not enclosed for relaxation in Examination Fee and the upper age limit (vi) Examination fee being in any other form except Indian Postal Order (vii) Certificates of Educational qualification and Cultural achievements not enclosed (viii) Two personal identification marks not mentioned in the application form (ix) Declaration not written on the application form in the candidate's hand writing (x) Left Thumb Impression and signature not done on the application form (xi) Signature in capital letters (xii) Not affixing self attested photograph on the application form (xiii) Not making all the entries in the application form (xiv) Canvassing, pressurising or trying to influence in any manner regarding recruitment/candidature.

**Note:** (1) In Case of difference between English and Hindi versions of the Employment Notice the English version shall be applicable. (2) The decision of RRC/NER in all matters relating to eligibility, acceptance or rejection of the application, issue of free journey pass, penalty for false information, method of recruitment, conduct of examination, allotment of Examination centre, and all other matters related with recruitment process will be final and binding on the candidates. Any enquiry or correspondence will not be entertained in this connection. (3) Any legal issues arising out of or in connection with this employment notice shall fall within the legal jurisdiction of Central Administrative Tribunal, Allahabad. 
