- **Note:-** (I) The number of training slots shown in this Notification are provisional and the same are liable to increase or decrease depending upon the actual needs of the administration at the time of finalization of selection and is inclusive of PWD & Ex-SM slots.
  - (II) When the prescribed number of persons belonging either to the Scheduled Castes OR to the Schedule Tribes are not available, the training places so reserved for them may be filled by persons belonging to the Schedule Tribes OR as the case may be, to the Schedule Caste, and if the prescribed training places can not be filled even in the above given manner, then the training places so lying unfilled may be filled by persons not belonging to the Schedule Caste OR the Schedule Tribe. Similarly the seats remaining unfilled by OBC candidates be filled by UNRESERVED category.
  - (III) An Ex-servicemen candidate selected under the reservation provided for them is to be placed in the appropriate category viz. UR/SC/ST/OBC to which he belongs. Exservicemen, their children and children of Armed Force personnel will be engaged for Apprenticeship as per details mentioned below:
    - a) Children of deceased/disabled Ex-servicemen including those killed/disabled during peace time.
    - b) Children of Ex-servicemen
    - c) Children of Serving Jawans
    - d) Children of Serving Officer
    - e) Ex-Servicemen
  - (IV) Person with Disability (PWD) who wants to avail the benefit of reservation must produce a disability certificate issued by a competent authority i.e. Medical Board duly constituted by the Central or State Government including one specialist in the particular field for assessing disability. PWD candidates will be considered for training if his/her disability is suitable for the trade notified and applied according to the Act Apprentice Rules as applicable in Railway <u>click here</u>. Accordingly it is advised to the candidates that it must be ensured about the suitability of their candidature with reference to their disability and identification of the trade to the said disability under the rules.

## 2.0 ESSENTIAL QUALIFICATION:- (as on date of issue of notification)

The candidate must have passed 10<sup>th</sup> class examination or its equivalent (under 10+2 examination system) with minimum 50% marks, in aggregate, from recognized Board and must have passed ITI in relevant trade recognized by Government.

## 3.0 Age Limit: (as on 27/01/2018.)

- 3.1 The candidates should have completed 15 years of age and should not have completed 24 years of age as on 27-01-2018.
- 3.2 Upper age limit is relaxable by 05 years in case of SC/ST candidates, 3 years in case of OBC candidates.
- 3.3 For Persons with Disability, upper age limit is relaxed by 10 years.
- 3.4 Upper age limit is relaxable by up to additional 10 years for ex-servicemen to the extent of service rendered in Defence Forces plus 03 years provided they have put in a minimum of 6 months service at a stretch, except Ex-servicemen who have already joined the Govt. service on Civil side after availing the servicemen status for the purpose of their engagement. However, regardless of community, Ex-servicemen will be considered against the Ex-servicemen quota, if available. If UR vacancies are not available then only Ex. serviceman belonging to those particular communities where vacancies are available will

be considered against the ex-servicemen quota.

- 3.5 The candidates who want to avail the benefit of reservation of SC/ST, must produce his/her Caste certificate on Central Government format issued by appropriate authority at the time of Document Verification. Similarly, the candidates who want to avail the benefit of reservation of OBC, must produce Caste certificate and Non-Creamy Layer Certificate issued on or after 1/4/2017 on Central Government format by appropriate authority.
- 3.6 The candidates who want to avail the benefit of reservation of Ex-servicemen and Armed Forces Personnel, must produce Discharge certificate and in case of children of Exservicemen and children of Armed Forces Personnel, they must produce discharge certificate or Armed Forces serving certificate respectively (as the case may be) of his/her parents at the time of document verification.
- 3.7 The candidates who want to avail the benefit of reservation of PH/PWD must produce PH/PWD certificate issued by competent authority under the rules.

## 4.0 APPLICATION FEE (NON REFUNDABLE) Rs. 100/- :

- **4.1** Application fee is to be paid through **ONLINE MODE** and RRC will not accept Application fee in Cash/ Cheque/ Money order/IPO/ Demand Draft Central Recruitment Fee Stamps etc. Candidate to note that RRC/NR is not responsible for incomplete or pending online examination fee transaction for whatever reason. In such case candidate need to proceed with fresh/new transaction of payment of application fee. Transaction charges for online payment, if any, will be borne by the candidates. On successful completion of the transaction, ereceipt with the date entered by the candidate will be generated, which should be printed and retained by the candidate.
- **4.2** No fee is required to be paid by SC/ST/PH/Women candidates.

5.0 MODE OF SELECTION : The procedure for engagement of candidate will be as under:-

- 5.1 Screening & Scrutiny of the application.
- **5.2** Selection of Act Apprentices is to be made on the basis of merit prepared taking the average of the percentage marks obtained by the candidate in both Matriculation (with min. 50% aggregate marks) & ITI examination giving equal weightage to both. In case of two candidates having the same marks, the candidate having older age shall be preferred. In case of the Date of Birth are also same, then the candidate who passed matriculation exam earlier shall be considered first.

For the purpose of calculation of percentage of marks of SSC of candidates from Boards where grading system is applicable, RRC will take midpoint of range of grades obtained by the candidates. After obtaining midpoints of all the attempted subjects according to grades awarded, average will be calculated treating each subject is out of 100 marks, as there is no standard method or multiplying factor for calculation of average of matriculation for such Boards.

**5.3** A final merit list will be prepared cluster, trade wise and community wise, equal to the number of slots in the descending order of percentage of marks obtained by the candidate in 10<sup>th</sup> Class & ITI, as stated above in para 5.2.

#### 6.0 Physical Fitness :

A person shall be ELIGIBLE for being trained under the Apprentices Act 1961 and Apprenticeship Rules 1992 as amended from time to time, if he/she satisfies the minimum standards of physical fitness as prescribed in the aforesaid Act and Rules and the standards prescribed for imparting training to the relevant trades which will be certified by a Railway Doctor.

#### 7.0 <u>Period of Training & Stipend</u>– As per Rules applicable.

#### 8.0 AGREEMENT OF TRAINING

Before commencement of the Apprenticeship training in the designated trade, the selected

candidate has to enter into a Contract of Apprenticeship Training as applicable. In case the selected candidate is minor then, his/her guardian has to enter into a Contract of Apprenticeship with the employer.

## 9.0 GENERAL INSTRUCTIONS

- (i) Merely Registering/filling up online application on RRC website does not entitle the candidate being eligible for selection process.
- (ii) Railway Administration reserves the rights to engage eligible candidates.
- (iii) The decision of Railway Administration on all matters relating to eligibility, place, date, mode of selection, acceptance or rejection etc. shall be final and binding on the candidates.
- (iv) The candidature of the applicants shall be liable to be rejected at any stage of selection/engagement process in case of concealment of any fact, which is in contravention to the above laid down conditions. - (ii) Applications without photograph, LHT impression, unsigned application/ Signature in capital or different signature at different places during the selection process.
- (iii) Applications without fee or less fee.
- (iv) Applications without proof of date of birth, 10<sup>th</sup> pass mark sheet, ITI certificate & mark sheets etc.
- (v) Over age or under age.
- (vi) Self-attested photocopies of requisite certificates not uploaded.
- (vii) Not having requisite educational qualification & ITI qualification at the time of applying.
- (viii) Application which are filed in a language other than English or Hindi.
- (ix) Any other irregularities which are considered invalid by RRC.
