Jharkhand Space Application Center (JSAC), Ranchi has to recruit bright, hardworking, reliable and competent professional on purely contract basis for the project executed in JSAC. The posts are on contract basis for a minimum period of one year.

The reservation rules of Government of Jharkhand will be applicable for OBC, SC and ST for the candidate having their domicile in the State of Jharkhand for which they will have to attach a copy of relevant caste certificates and domicile certificate issued by Competent Authority along with their application. The candidates belonging to reserved categories from State, other than Jharkhand, will be treated as General Candidates. In case vacancy is available in the General category against a particular post, their merit will be prepared in the General category only. The details of the posts and emoluments are as follow;

Qualification

a. Minimum Essential Educational Qualification

M.Sc. or M. Tech. in Remote Sensing and GIS / Geoinformatics from recognized university with first class.

b. Desirable Qualification

Working experience in image processing and GIS software.

Age Limit (As on 01.09.2016)

30 Years (35 Years for ST candidates).

Selection Procedure

The candidates will be screened out on the basis of minimum required qualification. The screened candidate will be called for interview and the final list will be prepared on the basis of merit list of interview. Intimation of interview will be sent separately to the eligible candidates. Decision of JSAC will be final in this regard.

The Minimum Essential Educational Qualification, experience and job profile is given above. Candidates are required to ensure that they meet the essential minimum qualification in all respects before applying. In case a candidate is found ineligible at any stage, even after appointment, his/her candidature will be cancelled.


Pay and Allowance

Important Documents


1. Applications should be accompanied with attested true copies of the
 - a. Mark sheets of SSC, Intermediate, Graduation, Post Graduation, Diploma, and any other documents related with qualification as desired.
 - b. Work experience Certificate.
 - c. Certificate of Matric as proof of date of birth
 - d. Caste Certificate issued by competent authority.
 - e. Residential Certificate by competent authority.
 - f. Two recent passport size photographs.
 - g. The Demand Draft as per requirement.
2. Candidates will have to produce original copies of the annexed documents at the time of interview.

Applications without the requisite information in the prescribed format without signature/without photograph/without attested true copies of the testimonials and mark sheets/without enclosures and incomplete, and those received after due date shall be rejected. The JSAC will not be responsible for any postal delay and no consideration will be made.
4. Mere fulfillment of the qualitative requirements of the post will not entail a candidate to be called for interview.
