Eligibility Criteria:

- 1. Only Ex-Servicemen can apply
- 2. Age should not be more than 45 years as on 01st July 2016.
- 3. Should have passed 10th standard but should not have passed the Higher Secondary Examination of 10+2 (10+2+3 pattern).
- 4. Should have served in 'FIGHTING ARMS' in the Indian Army or equivalent in Indian Navy or Indian Air Force.
- 5. Should be of rank up to HAVILDAR or equivalent rank in Navy & Air Force only.
- 6. Medical category at the time of Discharge should be SHAPE 1
- 7. Character at the time of discharge should be 'EXEMPLARY'
- 8. Proficiency in Tamil is mandatory.

Mode of Selection:

- 1. Screening of applications Incomplete application and applications received without enclosures will be summarily rejected.
- 2. Physical fitness test Test will comprise of 5 meter shuttle, Push ups and Sit ups. (Minimum Qualifying Standards-5 meter shuttle 11 times in a minute, 13 Push ups, 20 Sit ups)
- 3. Objective type Written test (in English) Test will be on General Knowledge, Simple Arithmetic and Reasoning, Knowledge in security aspects and Basics of Banking.

Those who qualify in Physical fitness test alone will be allowed to appear for the Written Test.

Eligible ex-servicemen should apply in the prescribed application available in the 'career' page of our website <u>www.indianbank.in</u> affixing recent passport–size photo and enclosing copies of (i) Discharge Book, (ii) Proof of Date of Birth, (iii) Caste/Community Certificate, (iv) Educational Qualification Certificate.

Applications received in any form other than in the prescribed application and without copies of the enclosures mentioned above will not be accepted.
