Applications are invited from the eligible local candidates for filling up of 10 (ten) posts of Firemen out of which 4 (four) posts i.e. 45% is reserved for Home guards and 1 (one) post i.e. 5% is reserved for Followers and 5 (five) posts i.e. 50% is reserved for direct on temporary regular basis in PB-1 of 5200-20200 plus Grade Pay of 2400/- under Fire & Emergency Services Department, Government of Sikkim, through Direct Recruitment.

However, during the period of Probation/Apprenticeship/Training, pay shall be governed by Notification No: 489/GEN/DOP dated: 31.10.2011.

### 3. Requirements for

**Home Guards Candidate :** (a) Should have completed 03 years of service as on 30.09.2016

- (b) Should be in possession of an enrolment or discharge certificate issued by Deputy Commandant General, Home Guards.
- (c) Should not have been charged for offence(s) and punishment listed under 15(2) of the Sikkim Home Guards Rules, 1993.
- **4. Duties of the post** : Fire Fighting & Rescue Operation, Telephone duty at Fire control Room, Dak duty, Etc.

5. *Age* 

Should have attained the age of 18 years, but should not have exceeded 22 years as on 31.07.2016. The maximum age limit is relaxable by 05 years in case

The maximum age limit is relaxable by 05 years in case of SC/ST/BL/PT candidates, 04 years for OBC (Central List) candidates, 03 years for OBC (State List) candidates. The candidates applying under Home Guards reserved quota the maximum age limit is as for the direct candidates category wise. Further, the candidates applying under Followers reserved quota the maximum age limit is 40 years.

- **9. Application form and syllabus can be downloaded from <u>www.spscskm.gov.in</u>. The form should be filled up by the candidate himself/herself and submitted in the office of the Sikkim Public Service Commission on any working day between 10:30 am. to 03:30 pm along with <b>original Bank Receipt of State Bank of Sikkim, for Rs. 150/- credited to '0051-SPSC'**. The amount once deposited shall not be refunded or adjusted against any other purpose.
- **10.** The complete filled in application form along with attested documents should reach the Secretary, Sikkim Public Service Commission, Old Tourism Office, M. G. Marg, Gangtok by hand or by post **on or before 03.00 pm. on <u>05.11.2016</u>**.
- 11. No application submitted after **03.00 pm. on <u>05.11.2016</u>** will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise.
- 12. One stamp size photograph should be affixed on the application form in the space provided and **two identical stamp size photographs** with the candidates name on the back side of the photograph should be submitted along with the application form.
- 13. Before filling the application form, candidate should go through the advertisement and accordingly they should fill the forms. Those claiming reservation should categorically specify the categories to which he/she belongs in the box provided in the application form.
- **14.** Those candidates who qualify in the written examination will be called for interview in the ratio as fixed by the Notification. No TA/DA is admissible for attending the examination/Interview.
- 15. Admission at all the stages of examination for which candidates are admitted by the Commission viz. Physical Endurance-cum-Eligibility Test, Main (written) Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.
- 16. The Commission will not entertain any application on review or RTI/Correspondence till the entire process of recruitment is complete.
