3. **ESSENTIAL QUALIFICATION**:

Candidates must possess valid GATE scorecard of GATE 2020 or 2021 or 2022 in Electronics & Communication (GATE code: EC) or Computer Science & Information Technology (GATE code: CS) along with:

- I. **B.E or B.Tech in the fields of**: Electronics or Electronics & Telecommunication or Electronics & Communication or Electronics or Information Technology or Computer Science or Computer Engineering or Computer Science & Engineering; from a Government recognized University/College/Institute. **Or**
- II. **Master's Degree** in Science with Electronics or Physics with Electronics or Electronics & Communication or Computer Science; **or Master's Degree** in Computer Applications; from a Government recognized University/College/Institute.

4. AGE LIMIT, RESERVATIONS & RELAXATIONS: 18-27 years

- a) Upper age limit is relaxable by 5 years for SC/ST & by 3 years for OBC.
- b) Upper age limit is relaxable for departmental candidates' upto 40 years of age who have rendered 3 years of regular and continuous service.
- c) The age limit is relaxable up to age of 35 years for general candidates and up to 40 years for SC/ST in case of widows, divorced women and women judicially separated from their husbands and not remarried.
- d) The age limit is relaxable for ex-servicemen as well as for the children & dependents of victims of communal riots of 2002 in Gujarat & victims of Sikh riots of 1984 as per the Govt. instructions in this regard issued by the Central Government from time to time.

- d) Successful completion of training is mandatory for confirmation to the post of ACIO-II/Tech.

- 3. **SERVICE LIABILITY**: The post involves All India Service liability. Therefore, the candidates willing to serve anywhere in India only need to apply.

4. SCHEME OF EXAMINATION:

Candidate has the option to provide his/her best GATE score from amongst GATE 2020 or 2021 or 2022.

- 2) The interview is aimed to assess the candidate's traits on two parameters i.e. Subject knowledge in relevant fields & Communication skills.
- 3) The final merit list will be prepared on the basis of candidates' combined marks obtained in Gate examination as well as in Interview.

Note: Candidates appearing in interviews will be required to appear in a Psychometric/Aptitude test, which will be a part of the Interview process.

5. SELECTION OF CANDIDATES:

- a) Candidates (10 times the number of vacancies) shortlisted on the basis of valid GATE score card will appear directly for the Interview at Delhi.

8. **HOW TO APPLY**:

- b) Candidates can apply for the post provided they fulfill the prescribed eligibility conditions.
- c) The application portal will be operational from 16.04.22 to 07.05.22 (till 2359 hrs). Registration done prior to 16.04.22 & after 07.05.22 will not be accepted.
- d) Candidates should have a valid personal e-mail ID & mobile number. It should be kept active during the entire recruitment process.
- e) Registration number, password & all other important communications/alerts will be sent on the same registered e-mail ID.
- f) Candidates should upload the scanned (digital) image of their photograph and signature.
- g) Coloured photo of size 35mm (width) x 45mm (height) not older than 12 weeks should be uploaded. Black & white photo will not be accepted.
- h) Photo should be in light background. Light grey/white is suggested. No patterns.
- i) The face should cover 70-80% of the photo. The applicant should look straight at the camera with a normal expression.
- j) Avoid uniform of colours matching the background.
- k) If the applicant wears optical glasses, then his/her eyes should be fully visible in photo.
- I) The size of scanned image should be between 20-50kb in jpg/jpeg format only.
- m) The applicant has to sign on white paper with Black ink pen.
- n) The signature must be signed only by the applicant and not by any other person.
- o) Please scan the signature area only and not the entire page.
- p) The size of scanned signature should be between 10-50kb in jpg/jpeg format only.
- Before submitting the online application, the candidates MUST preview the q) application to ensure that they have provided correct information, particularly the email id & uploaded correct photograph & signature. It must also be ensured that the photograph & signature are visible & not hazy/blurred, otherwise the photograph & signature should be uploaded again or the page should be reloaded or refreshed. 11. GENERAL INSTRUCTIONS:

- **b)** Caste certificates would be accepted as per the govt's instructions in vogue.
- c) The date of birth as well as the name of the applicant will invariably be taken from the matriculation certificate issued by a recognized board. No other proof of date of birth and name shall be accepted.
